Harold and Peter farmed in a traditional way and there is a comprehensive range of tractors, machinery, and livestock equipment, all of which have been looked after with few hours on the tractors and of particular note is the Case International 4230 tractor a 1996 model which has only approximately 6,500 hours on the clock, the Case International 695 tractor and the Massey Ferguson 240 Combine with a 8'6" cut. There is also a wide range of farm machinery including the 10' Ifor Williams livestock trailer, Samasz two drum mower, trailers, cultivation equipment, drills and conventional balers, small tools and sundry items and also a range of collectable vintage items of machinery, collectable antique dairy equipment, a stone trough, antique water pumps, dolly tub, two copper milking machine buckets etc.

We wish Harold and Peter all the best in their retirement, and they were also great supporters of Congleton Cattle Market showing pigs and fat cattle virtually on a weekly basis.

The sale will commence at 11.00 a.m. prompt with the small tools and sundries followed by the machinery and tractors.


